WHEREAS the Petitioners have presented under Sections 10 to 12 of the Contempt of Courts Act 1971, above case through its counsel M.RAMGOPAL RAO, praying that this Hon'ble High Court may be pleased to punish the respondents herein for their willful, disobedience and disrespect to the orders in O.A.No.470 of 2017, dated 23.02.2017;

WHEREAS the said case coming on for hearing on this day and whereas the High Court upon perusing the affidavit filed herein and the order

of High Court dated 06.11.2023 made herein and upon hearing the arguments of M/s M.Ramgopal Rao, Advocate for the Petitioners and of Sri V.K.Naidu, Advocate for the respondent No.1, made the following

ORDER:

"Learned counsel for the petitioner is present.

On 23.02.2017, the Andhra Pradesh Administrative Tribunal disposed of O.A.Nos.470, 471 and 472 of 2017 with the following direction:

"...I have gone through the order of the Tribunal passed in O.A.No.317 of 2017 dated 10.02.2017 and satisfy that the subject matter of these OAs is covered by the orders of the Tribunal in O.A.No.317 of 2017 dated 10.02.2017.

In view of the above, these OAs are disposed of as covered by the orders passed in O.A.No.317 of 2017 dated 10.02.2017."

The order passed in O.A.No.317 of 2017 dated 10.02.2017 reads as follows:

"...In view of the above facts and circumstances, the respondents are directed to consider the case of applicants for promotion to the posts of School Assistant (Hindi), in the vacancies that arose prior to 05.02.2017, if they are otherwise eligible and qualified, as per the amended Rules issued in G.O.Ms.No.15, Education Department, dated 05.02.2017."

As the State has carried the Writ Petition questioning the order passed in O.A.No.317 of 2017, the said Writ Petition can be dismissed.

The contempt application was filed against the non-implementation of the order dated 23.02.2017 passed by the Andhra Pradesh Administrative Tribunal in O.A.No.470 of 2017 and C.A.No.420 of 2017 was renumbered as C.C.(AT).No.48 of 2023.

In view of the same, Registry is directed to issue notice to the designated respondent No.1.

Post the matter after four (04) weeks.

Registry is directed to communicate this order to the office of the respondents."
