WHEREAS the said case coming on for hearing on this day and whereas the High Court, upon perusing the affidavit filed herein and the order of High Court dated 24.11.2023 made herein and upon observing that there is no representation on behalf of learned counsel for the petitioner, made the following

ORDER:

"No representation on behalf of learned counsel for the petitioner.

On 01.02.2017, the Andhra Pradesh Administrative Tribunal disposed of the O.A.Nos.184 and 185 of 2017 by a common order with the following direction:

"In the result, the two Original Applications are disposed of at the admission stage directing the Director of Public Health and Family Welfare, Andhra Pradesh, Hyderabad, now at Vijayawada to consider and dispose of the appeals, if any pending in these matters, on merits and as per rules, within a period of 2 months from the date of receipt of copy of this common order."

The contempt application was filed in the year 2017 and C.A.No.256 of 2017 was renumbered as C.C.(AT).No.71 of 2023.

In spite of receipt of notice, no Vakalat is filed and no instructions are forthcoming from the respondent.

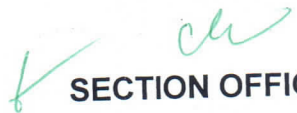
In view of the same, the designated respondent is hereby informed to place the written instructions/compliance report before this Court by the next date of hearing.
