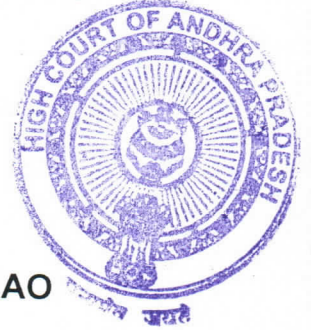

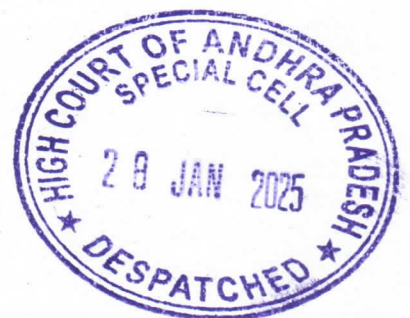

You are also further directed to return this warrant as early as possible preferably on or before **04.02.2025** to this Court with a detailed report stating the manner in which it has been executed.
