When the matter is listed today, again learned counsel attached to the office of the Deputy Solicitor General sought adjournment. However, his request is considered, subject to complying with the order of this Court by the

next date of hearing, failing which, the Respondent Nos.1 and 2 shall appear before this Court in person on 19.6.2023.
