The learned counsel for the petitioner submits that the orders of this Hon'ble Court in W.P.No. 16158 of 2022 dated 17.06.2022 has not been complied with till date. The action of the respondent is deliberate and wanton in order to flout the orders of this Hon'ble Court.

In view of the above said allegations made in the Contempt case, the Registry is directed to issue notice to the respondent returnable within four (4) weeks.
