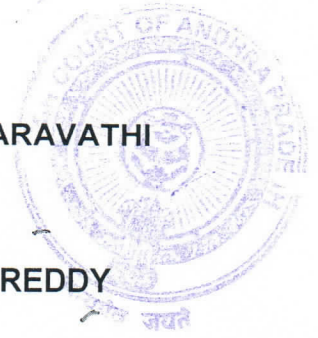

There shall be an interim stay of all further proceedings in C.C.No.282 of 2014 on the file of the learned III Additional Chief Metropolitan Magistrate, Visakhapatnam at Gajuwaka, for a period of eight (8) weeks.

Post the matter after six (6) weeks."

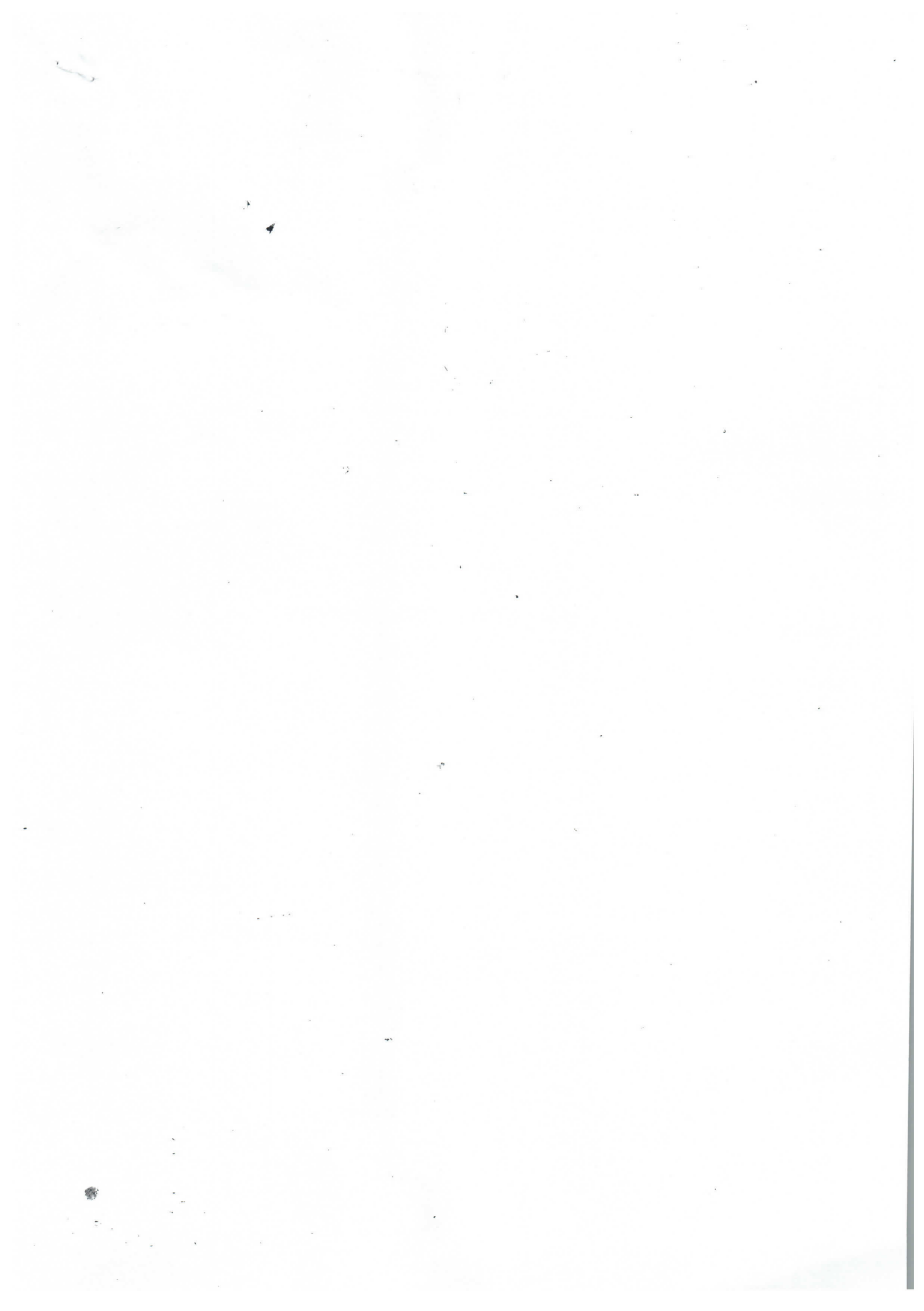
