Issue notice to respondent No.2.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by RPAD and file proof of service in the Registry within a period of three (3) weeks.

In the meanwhile, the police concerned are directed to conduct investigation without taking any coercive steps against the petitioner herein. It is made clear that the police shall not insist the petitioner herein to attend the Police Station, more so when the petitioner is the mother of accused No.1 and she is residing at different place i.e., at Hyderabad.

List the matter after six (6) weeks."
