Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to stay all further proceedings in FIR.No.402/2022 on the file of the Pattabhipuram Police Station, Guntur District, pending disposal of CRLP No. 1543 of 2023, on the file of the High Court.

ORDER:

“Learned Assistant Public Prosecutor takes notice for the respondent No.1 and seeks time to get instructions in the matter.

Issue notice to respondent No.2.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by RPAD and file proof of service in the Registry within a period of three (3) weeks.

In the meanwhile, there shall be interim stay of all further proceedings in Crime No.402 of 2022 of Pattabhipuram Police Station, Guntur district, for a period of eight (8) weeks.

List the matter after six (6) weeks.”
