Learned counsel for the petitioners is permitted to take out personal notice to respondent No.2 by RPAD and file proof of service in the Registry within a period of three (3) weeks.

In the meanwhile, the presence of the petitioners 1, 2 and 4 to 9 herein before the trial Court is dispensed with, except on those dates when the learned Magistrate feels that their presence is necessary. It is made clear that petitioner No.3 herein shall attend before the trial Court on all the adjournments on his behalf and on behalf of petitioner Nos.1, 2 and 4 to 9, for a period of eight (8) weeks.

List the matter after six (6) weeks.”
