Till then, interim order granted earlier is extended."

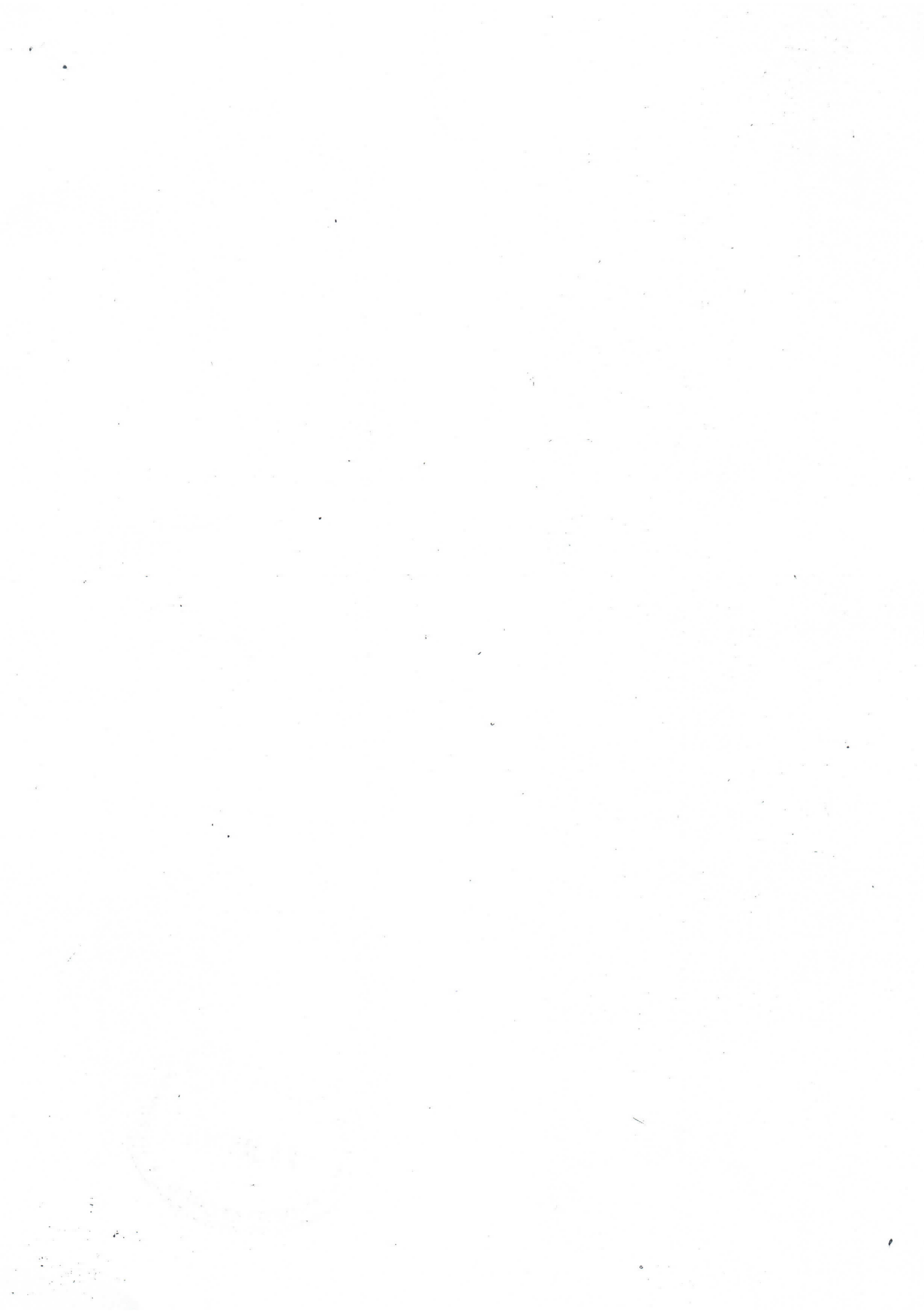
