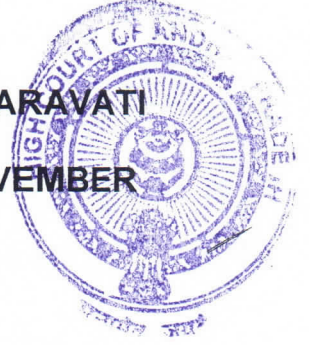

Bhavanipuram P.S., Vijayawada, which was registered for the alleged offences under sections 404,420,453 r/w 34 of IPC and to quash the same against the petitioners herein as it is illegal, arbitrary, unjust and abuse of process of law and the allegations do not attract the ingredients of the alleged offences .
