A perusal of material on record goes to show that except vague and bald allegations that the petitioner herein was asked to come along with A1 and others, there is no specific act that the petitioner herein is involved in the day to day affairs of the transactions between the defacto complaint and A1.

In view of the above, police are directed to conduct investigation without taking any coercive steps as against the petitioner herein.

Post the matter after four (4) weeks."
