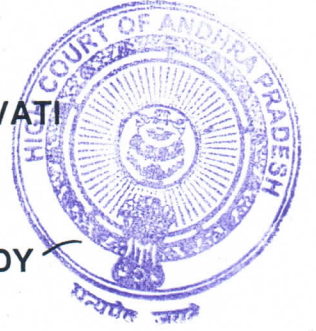

Judicial First Class, Magistrate Tenali, Guntur District, Andhra Pradesh and quash the same in so far as the petitioners/A-4 and A-5 are concerned as the same is illegal, arbitrary and abuse of process of law. ✓

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Smt. PASUPULATI ANITHA Advocate for the Petitioner and of Public Prosecutor for Respondent No.1, directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

Petition under 482 of Cr.P.C praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to grant stay

of all further proceedings including appearance of the petitioners/A4 and A5 in C.C.No.No. 911 of 2022, on the file of II Addl. Judicial First Class, Magistrate Tenali, Guntur District, Andhra Pradesh, pending disposal of CRLP No. 5376 of 2023, on the file of the High Court.

The Court made the following:

ORDER:

"Learned Assistant Public Prosecutor takes notice for respondent No.1 and seeks time to get instructions in the matter.

Issue notice to respondent No.2.

Learned counsel for the petitioners is permitted to take out personal notice to respondent No.2 by RPAD and file proof of service before the Registry within a period of three (3) weeks.

Going by the charge sheet, except making an omnibus accusation against the petitioners herein that they supported A1 in harassing the de facto complainant, no specific overt act has been attributed against them.

In view of the same, there shall be interim stay of all further proceedings including appearance of the petitioners herein/A4 and A5 in CC No.911 of 2022 on the file of learned II Additional Judicial Magistrate of First Class, Tenali, Guntur district, for a period of eight (8) weeks.

List the matter after six (6) weeks."
