WHEREAS the Petitioner/Accused above named through her Advocate Sri Ch B R P Sekhar presented this Petition under Section 482 of Cr.P.C, praying that in the circumstances stated in the memorandum of grounds filed in support of the Criminal Petition, the High Court may be pleased to Quash the CC No 3711 of 2022 on the file of The II Addl Chief Metropolitan Magistrate, Vijayawada, Krishna District against the petitioner in interest of Justice

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri CH B R P SEKHAR Advocate for the Petitioner, Special Assistant Public Prosecutor for Respondent No.1, directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are be and hereby directed to show cause either appearing in person or through an Advocate, as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted within four weeks.

Petition under Section 482 of Cr.P.C, praying that in the circumstances stated in the memorandum of grounds filed in support of the petition, the High Court may be pleased to grant stay of all further proceedings against petitioner in CC No 3711 of 2022 on the file of The II Addl Chief Metropolitan Magistrate, Vijayawada,

Krishna District including appearance of the petitioner, pending disposal of CRLP No. 5494 of 2023, on the file of the High Court.
The Court made the following order :

"Learned Special Assistant Public Prosecutor takes notice on behalf of 1st Respondent and seeks time to get instructions.

Issue notice to respondent No.2.

Learned counsel for the petitioner is permitted to take out personal notice to Respondent No.2 by Registered Post with Acknowledgment Due and file proof of service within a period of three (3) weeks.

A perusal of charge sheet goes to show that, no specific overtact has been attributed as against the petitioner herein except stating that the petitioner herein has frequently visited the house of A1 and harassed the defacto complainant. It is submitted by the learned counsel for the petitioner that the petitioner herein is working as Office Assistant in Sangam Dairy at Vadlamudi.

In view of the aforesaid facts and circumstances, there shall be an interim stay of all further proceedings, in respect of petitioner herein only i.e. A4, in C.C.No:3711 of 2022 on the file of the learned II Additional Chief Metropolitan Magistrate, Vijayawada, for a period of six (6) weeks.
