Petition under Section 482 of Cr.P.C, praying that in the circumstances stated in the memorandum of grounds filed in Criminal Petition, the High Court may be pleased to quash the order of rewarding compensation under Section 250 Cr.P.C against the petitioner in Judgment dated 16.12.2022 in C.C. No. 59 of 2018 on the file of the Special Judicial Magistrate of First Class (Mobile)-Cum-III Additional Junior Civil Judge, West Godavari at Eluru and the Show cause notice dated 16.12.2022 issued U/s 250 Cr.P.C against the petitioner in the interest of justice.

There shall be an interim stay of all further proceedings in C.C.No.59 of 2018 on the file of learned Special Judicial Magistrate of First Class (Mobile)-cum-II Additional Junior Civil Judge, West Godavari at Eluru, for a period of eight (8) weeks.

Post after six (6) weeks.”

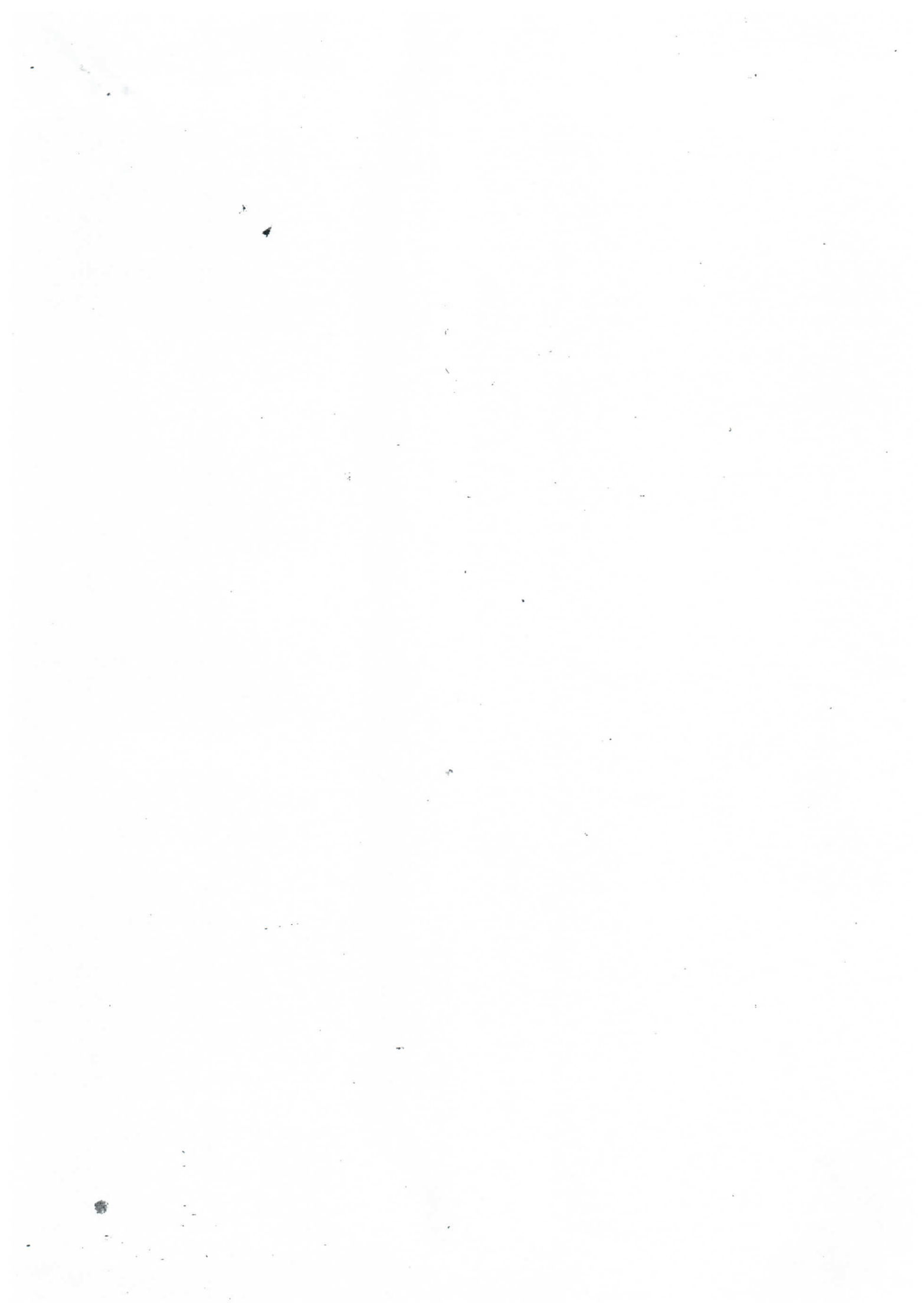
