IA NO: 2 OF 2023:

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the memorandum of grounds filed in support of the petition, the High Court may be pleased to suspend the operation of the impugned order dated 29.11.2022 passed in E.P.15 of 2017 in O.S.No.40 of 2008 by the Principal Junior Civil Judge Court, Bobbili, pending disposal of the main CRP.

The Court made the following Order:

"Issue notice to respondents 2 to 7.

Learned counsel for the petitioners is permitted to take out personal notice to respondents 2 to 7 by RPAD and file proof of service in the Registry within a period of three (3) weeks.

The petitioners herein/Judgment Debtors have categorically stated that they did not give the suit schedule building on rent to conduct any functions and only Yoga classes have been conducted in the said building, which has been done keeping in view the welfare of the public. It is also represented that against the judgment and decree passed in OS No.40 of 2008 they preferred an appeal in AS No.4 of 2017 on the file of the learned Senior Civil Judge, Bobbili and the same is pending.

In view of aforesaid reasons, there shall be interim suspension as prayed for, for a period of eight (8) weeks.
