“Sentence of imprisonment imposed by the Court below alone is suspended pending disposal of the Criminal Appeal, on condition of the petitioner surrendering before the learned Principal Special Judge for CBI Cases, Visakhapatnam, and on such surrender, the petitioner shall be enlarged on bail on executing a personal bond for the like sum of Rs.10,000/- (Rupees ten Thousand only) with two sureties for a sum each to the satisfaction of the learned Principal Special Judge for CBI Cases, Visakhapatnam.”
