Petition under Section 389(1) of Cr.P.C praying that in the circumstances stated in the memorandum of grounds filed in Criminal Appeal, the High Court may be pleased to release the petitioner on bail pending disposal of the appeal by suspending sentence imposed in S.C.No.154/2015 dt.11-01-2023 on the file of the VII Additional Sessions Judge, Nellore, SPSR Nellore District, Andhra Pradesh, pending disposal of CRLA No.136 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the memorandum of grounds filed in support thereof and upon hearing the arguments of Sri D Kodandarami Reddy, Advocate for the Appellant and of Public Prosecutor for Respondent, the court made following

ORDER:

"The present application is filed by A5 seeking bail on the ground that his health condition is not good and at present he is bed ridden in Jail Hospital.

A Medical Certificate came to be placed by the Medical Officer, Central Prison, Nellore is placed on record which is as under:

"This is to certify that a Convict Prisoner named by S.Raghavulu, aged 66 years, male, S/o Raghavaiah CT No.6981 was admitted into Central Prison, Nellore on 13.01.2023. At the time of admission he was examined by the jail medical officer and found that old T2DM, CAD, Hypertensive, old CVA, right hemiparesis, Temporoparietal and Capsuloganglionic bleed, craniotomy scar epilepsy. He was unable to walk. He is on Folly catheter and he was dependent on someone even for his daily needs personally.

On 23.01.2023 the said prisoner was referred to GGH Nellore on emergency basis for generalized seizures. The medical authorities of GGH Nellore treated him symptomatically and refer to higher center for further management and he was referred to SVRR Thirupathi on the same day. The medical authorities of SVRR Thirupathi admitted him and done several tests. 2D-Echo shows that LF-66%, Mild AR, Concentric LVH, Trivial MR, Grade I diastolic dysfunction and No PE/Clot/Veg. CT Brain shows that old gliotic change with no active bleed. On 25.01.2023, the said prisoner was discharged from SVRR Thirupathi. They prescribed medicines and review after 2 weeks.

At present he is being given required medication in this Jail Hospital as per the advice of SVRR Hospital, Thirupathi. His condition is Bedridden.

This certificate is issued at the request of prisoner for court purpose.

A reading of the said certificate would show that the condition of the petitioner is bad and is bed ridden.

Having regard to the above, we deem it appropriate to release the petitioner on bail for a period of three (3) months initially, on his executing a personal bond for a sum of Rs.20,000/- (Rupees Twenty thousand only) with two sureties for a like sum each to the satisfaction of the learned Additional Judicial Magistrate, Kovvur, SPSR Nellore District."
