Petition under Section 397 (1) Cr.P.C praying that in the circumstances stated in the memorandum of grounds filed in support of the petition, the High Court may be pleased to suspend the operation of sentence passed in judgment against the revision petitioner in CrI.A No. 252/2017 on the file of the XVI Addl. District and Sessions Judge at Nandigama, NTR District, Andhra Pradesh confirmed and modified the judgment of the Addl. Judicial First Class Magistrate, Nandigama in C.C. No.364/2015 dated 04-07-2017 sentencing the accused to undergo simple imprisonment for a period of 1 month and to pay fine of Rs.500/- in default of payment of fine the accused shall undergo simple imprisonment for a period of one weeks for the offence of under Section 337 of IPC; the appellant sentencing to undergo simple imprisonment for a period of 3 months and to pay fine Rs.1000/- in default of payment of fine the accused shall undergo simple imprisonment for a period of one month for the offence of under Section 338 of IPC; sentencing the appellant to undergo simple imprisonment for a period of 6 months by modifying sentence from 8 months and to pay fine of Rs.10,000/- in default of payment of fine the accused shall go simple imprisonment for a period of 3 months for the offence of under Section 304-A of IPC and the order passed by the Trial Court that out of fine amount paid by the accused awarded compensation to PW-5, is also confirmed petitioner on bail till the disposal of the main revision case, Pending disposal of CRLRC No. 285 of 2023, on the file of the High Court.
