The petitioner is ordered to be released on bail on his executing personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties for the like sum each, to the satisfaction of the Special Judge for Trial of Cases under NDPS Act-Cum-Additional District & Sessions Judge, Vizianagaram.”
