"I have heard learned counsel for the petitioner, Mr. R. Harish Kumar.

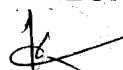

For the reasons stated in the affidavit of the petitioner, as minor child is under care and custody of the petitioner, all further proceedings including appearance of the petitioner in H.M.O.P. No.26 of 2023 on the file of Senior Civil Judge Court, Dhone are hereby stayed.
