Interim order granted earlier is extended till then.

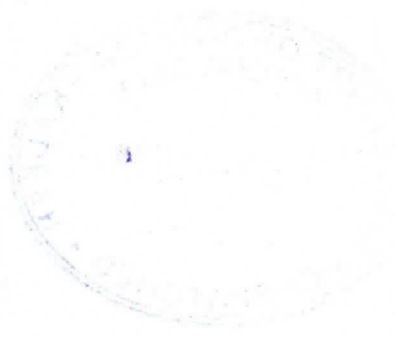

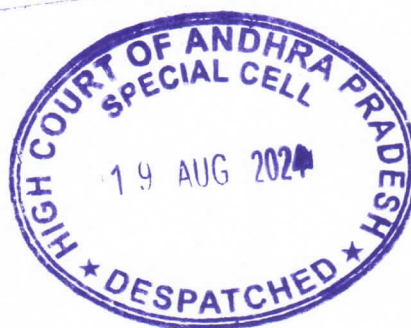
