Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to suspend the orders in Rc.B./ 106/2024, dt: 19-03-2024 of the 4th Respondent, pending disposal of WP No.10690 of 2024, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

“Assailing the notice issued by the Tahsildar, Veldurthi mandal, Kurnool District *vide* Rc.B./106/2024 dated 19.03.2024, the above writ petition is filed.

I.A.No.1 of 2024 is filed to suspend the proceedings of the Tahsildar, dated 19.03.2024.

Learned counsel for the petitioner would submit that the Tahsildar lacks jurisdiction to issue notice. In fact, the Tahsildar intends to cancel the Pattadar Pass book. He would also submit that the notice issued by the Tahsildar is contrary to the instructions of the Revenue Divisional Officer *vide* Rc.C/2299/2023, dated 17.02.2024.

A perusal of the notice impugned in the writ petition would indicate that the Tahsildar intends to cancel the Pattadar Pass book *vide* Khata No.3445 in Sy.No.645/2A2 of an extent of Ac.0.07 cents of Veldurthi Village.

Whether the Tahsildar got jurisdiction to cancel the Pattadar Pass book, requires consideration.

In view of the above, the notice issued by the Tahsildar, Veldurthi mandal, Kurnool District *vide* Rc.B./106/2024 dated 19.03.2024, is hereby suspended.”
