one in the nature of writ of Mandamus declaring the action of the 2nd respondent in not considering the cases of the petitioners for promotion to the post of Dy. Executive Engineer at RP 86 meant for Mental Illness and Roster Point 6 meant for VH in the promotions effected vide proceedings No.571/Ser.II(1)/Zone-IV/2021-8, 13.06.2023 illegal, arbitrary and violative of Articles 14, 16 and 21 of the Constitution of India and further declare that the petitioners are entitled for promotion to the post of Dy. Executive Engineer in the RP 86 and 6 by interchanging the disabled categories from Mental Illness and VH to OH category w.e.f., 13.06.2023 the date on which promotions granted to the respondents 3 and 4 with all consequential benefits.

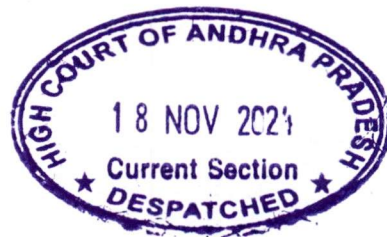
