ORDER:

"The present criminal petition is filed by Accused No.5 to quash the proceedings in Crime No.98 of 2022 for the offences under Sections 498-A, 494, 420, 506 IPC and Sections 3 & 4 of Dowry Prohibition Act. This Interlocutory Application is filed seeking to stay of all further proceedings including arrest of the petitioner in Crime No.98 of 2022.

Learned senior counsel would submit that the petitioner is nine months pregnant and memo is also filed to the said effect.

In view of the submissions made by the learned senior counsel for the petitioner, the respondents are directed not to take any coercive steps against the petitioner. However investigation shall go on."
