Petition under Section 397 (1) of Cr.P.C is filed praying that in the circumstances stated in the memorandum of grounds filed in support of the petition, the High Court may be pleased to enlarge the petitioner on bail, by suspending the conviction and sentence imposed by Calendar and Judgment dt. 04-09-2018 in CC 324 of 2016 on the file of the court of Learned Junior Civil Judge cum Judicial Magistrate of First Class, Bhimadole as was confirmed by the Judgment Dt.31.01.2023 in CrI.A No.382 of 2018 on the file of the court of Learned II Additional District Judge, West Godavari at Eluru, Pending disposal of CRLRC No. 91 of 2023, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case). The Court made the following

ORDER:

"In the circumstances, the sentence of imprisonment alone is suspended, pending disposal of the CrI.RC, and the petitioner is directed to surrender before the learned Judicial Magistrate of First Class, Bhimadole, within a period of two (2) weeks from today and on such surrender he shall be

enlarged on bail on his executing a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties for a like sum each to the satisfaction of the learned Judicial Magistrate of First Class, Bhimadole, and also on condition of his depositing 20% of the cheque amount within a period of eight (8) weeks from today. In default of deposit of cheque amount, as ordered supra, the interim suspension granted today, shall stand cancelled automatically without further reference to the Court."

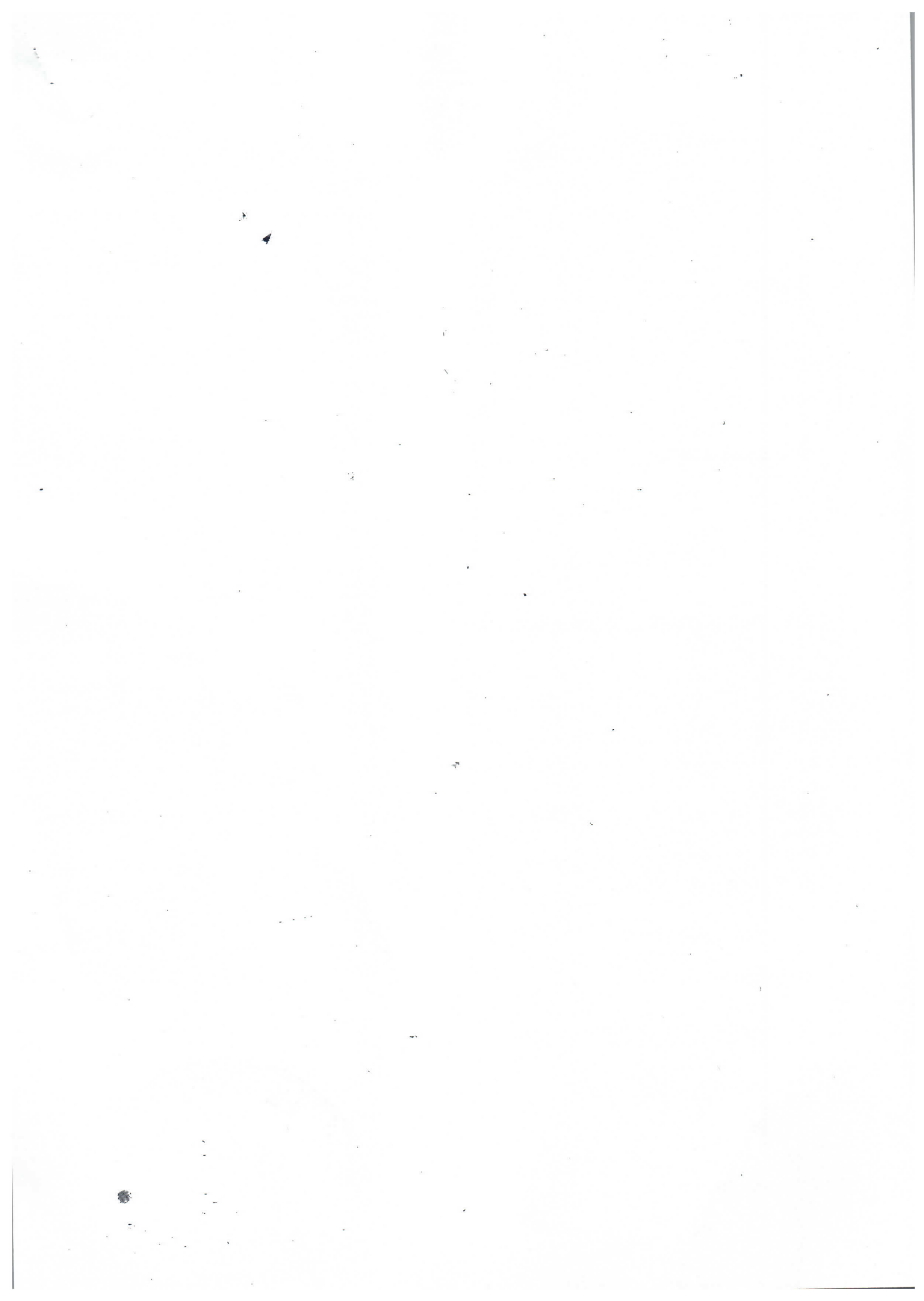
