No. 138 of 2018 by the Learned XII Additional District Judge cum VI Additional Metropolitan Magistrate Court at Vijayawada confirming the judgment and the sentence imposed in C.C.No. 117 of 2016, dated 25-05-2018 on the file of the II Special Magistrate, Vijayawada, Pending disposal of CRLRC No. 356 of 2023, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case). The Court made the following

ORDER

"In the circumstances, the sentence of imprisonment alone is suspended, pending disposal of the Criminal Revision Case, on condition of the petitioner herein surrendering before the learned II Special Magistrate, Vijayawada, within a period of two (2) weeks from today and, on such

surrender, she shall be enlarged on bail on her executing a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties for the like sum each to the satisfaction of the learned II Special Magistrate, Vijayawada, and also on payment of 20% of the cheque amount, within a period of eight (08) weeks from today. In default of payment of cheque amount, the interim suspension granted today shall stand cancelled automatically without further reference to the Court."
