ORDER:

“Pending disposal of the criminal revision case, the sentence of imprisonment imposed upon the petitioner alone is suspended and the petitioner shall surrender before the learned VI Metropolitan Magistrate, Vijayawada (learned

trial Judge), within a period of two weeks from today. On such surrender, the petitioner shall be enlarged on bail on his executing a personal bond for Rs.20,000/- (Rupees Twenty Thousand only) with two sureties for the like sum each to the satisfaction of the learned trial Judge."
