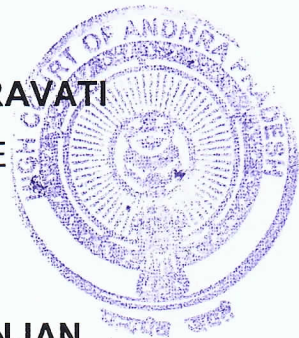

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the Award in ID No. 20 of 2018 dated 11.07.2022 on the file of the Industrial Tribunal cum Labour Court, Ananthapuramu, pending disposal of the Writ Petition No.11240 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the earlier order of the High Court dated 01.05.2023, made herein and upon hearing the arguments of M/s S M SUBHAN, Advocate for the Vacate Petitioner, and of M/s SOLOMON RAJU MANCHALA FOR (APSRTC), Standing Counsel for the Respondent Nos.1 to 4, the Court made the following

ORDER:

This Court has passed interim order, dated 01.05.2023, suspending the Award in I.D.No.20 of 2018, dated 11.07.2022, passed by the Industrial Tribunal-cum-Labour Court, Ananthapuramu, till the next date of hearing. Now, this vacate stay petition has been filed by the 1st respondent workman.

2. Learned counsel for the 1st respondent/ workman submits that in similar cases, this Court has passed interim orders of suspension of Award subject to the workman being reinstated into service and therefore, seeks to modify the interim order, dated 01.05.2023 accordingly.

3. Learned Standing Counsel appearing for the writ petitioners Corporation does not refute the same.

4. In view of the same, the vacate stay petition is disposed of by modifying the interim order passed earlier. The Award passed in I.D. No.20 of 2018, dated 11.07.2022, passed by the Industrial Tribunal-cum-Labour Court, Ananthapuramu, is stayed subject to workman being reinstated into service within six weeks from the date of receipt of a copy of this order.
