Sri. V Y Prabhuvu, presented this Petition under Article 226 of the Constitution of
India praying that in the circumstances stated in the affidavit filed therewith, the High
Court may be pleased to issue an appropriate writ, order or direction particularly in
the nature of Writ of **MANDAMUS** declaring the action of the respondents in not
considering the representations made by the Petitioner dated 28-03-2023, 24-01-
2023 requesting to release the pledged documents for the loan already closed by
splitting the properties as the Petitioner has pledged 5 properties for sanction of
limits, so as to enable the Petitioner for selling those properties since the interested
parties are ready to buy two properties; thereby settle the outstanding dues by way

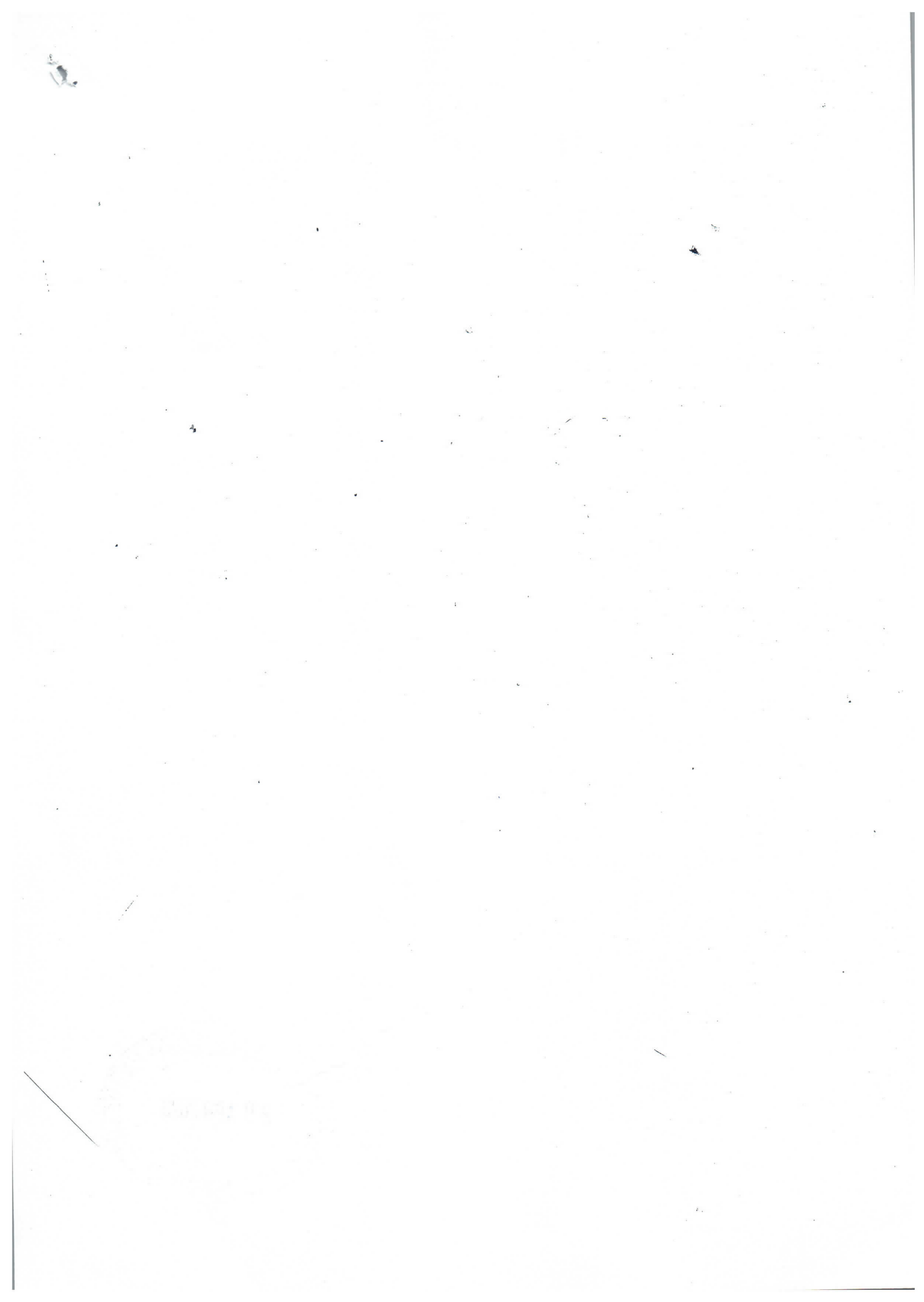
