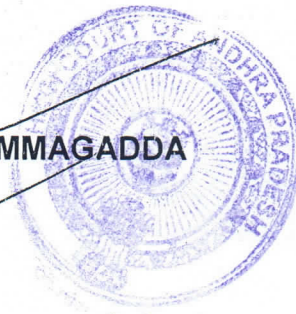

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF Certiorari declaring the Award in ID No 52 of 2016 dated 21.06.2022 on the file of the Industrial Tribunal cum Labour Court, Ananthapuramu, notified by GO Rt.No 269 dated 21.07.2022, as illegal, irregular, irrational, without application of mind, violative of principles of natural justice and Articles 14 and 21 of Constitution of India and set aside the same and consequently suspend the award in ID No 52 of 2016 dated 21.06.2022 on the file of the Industrial Tribunal cum Labour Court, Ananthapuramu .

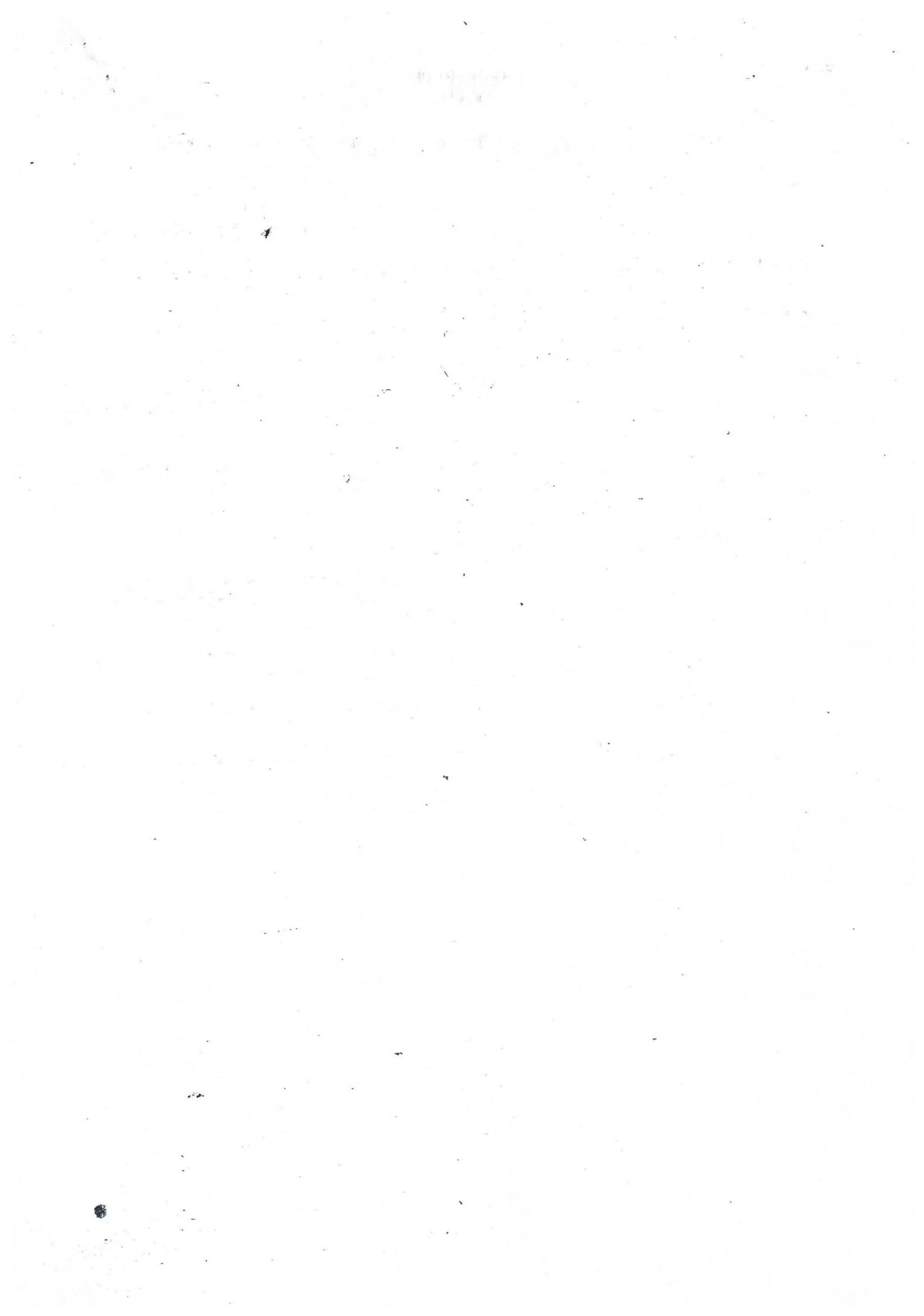
