WHEREAS the Petitioner above named through its Advocate Sri. Dasari S.V.V.S.V.Prasad, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents in not releasing the amount of Rs. 5,43,420/- (Rupees Five Lakhs Forty three thousand four hundred and twenty Only) for supplying the machineries/equipments to the Respondent authorities by the petitioner even though admitted amounts is illegal, arbitrary, unjust, unfair and violation of principles of natural justice, contrary to the Rules & Regulations and consequently, direct the Respondents to pay admitted amount of Rs. 5,43,420/- (Rupees Five Lakhs Forty three thousand four hundred and twenty Only) with cumulative interest;

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of Sri. Dasari S.V.V.S.V.Prasad, Advocate for the Petitioner, learned GP for Agricultural Dept., for respondent Nos. 1 & 3 and learned GP for Finance for respondent No.2, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
