WHEREAS the Petitioners above named through their Advocate Sri K Bheema Rao presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or direction more particularly one in the nature of Writ of Mandamus declaring the GOMs No.3 Skills Development and Training (E&T A.2) Department Dt.10.01.2023 issued by the 1st respondent to pay minimum of time scale attached to the post of the petitioners as illegal and arbitrary and further declare that the action of the respondent in not extending the benefit of payment of regular pay scales of pay to petitioners as was done in respect of the staff of other Institution taken over vide GOMs No.32, Labour employment Training and factories Department Dt.30.06.1999 as illegal Arbitrary and discriminatory and violation of Article 14, and 16 of the Constitution of India and consequently direct the

respondents to pay Regular pay scale to the petitioners herein on par with staff covered vide GOMs No.32, Labour employment Training and factories Department Dt.30.06.1999.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri K Bheema Rao Advocate for the Petitioner, GP FOR SERVICES III -for the Respondent Nos. 1 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
