Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any Writ, order or direction more particularly one in the nature of Writ of mandamus declaring the action of respondents in resorting to dispossess the petitioners from their respective plots as illegal, arbitrary and violation of Article 21, 14 and 300 A of the Constitution of India and to consequently direct the respondents not to interfere with the petitioners' residential plots situated in extent of 55 Sq Yds each in plot Nos. 253, 261, 254, 252, 255, 256, 248 and 262 respectively situated in an extent of 55 Sq Yds each in Sy No. 153/15 of Pedagantyada Village and Mandal, Visakhapatnam District covered by L.P. No. 25/96.

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to dispossess the petitioners from their residential plots Nos.253, 261, 254, 252, 255, 256, 248 and 262 respectively situated in an extent of 55 Sq Yds each in Sy No. 153/15 of Pedagantyada Village and Mandal, Visakhapatnam District covered by L.P No. 25/96, Pending disposal of WP 11831 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri V V SATISH Advocate for the Petitioners and of GP FOR REVENUE for the Respondent Nos.1 to 3 and of GP FOR LAND for the Respondent No.4, the Court made the following
