WHEREAS the Petitioner above named through his Advocate Sri. Suresh Kumar Reddy Kalava, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ of mandamus or any other appropriate writ or direction declaring the action of the Respondents in withholding the payment of amount of Rs.75,79,757/- (first bill), Rs.94,27,785/- (second bill) and Rs.30,20,678/- (final bill) totally an amount of Rs.2,00,20,220/- even after finalizing the bills payable to the petitioner in relation to the works i.e., Construction of Men's Hostel for Arts and Science Colloge at S.V. University, Tirupati" vide agreement Bond No.MD/LS/TW-VII/32/2021-22 dt.28.06.2021, is questioned, as the same is illegal, arbitrary and consequently direct the respondents to consider for payment amount of Rs.75,79,757, - (first bill), Rs.94,27,785/- (second bill) and Rs.30,20,678/- (final bill) totally an amount of Rs.2,00,20,220/- with interest @24% per annum for the delayed amount to the petitioner in respect of execution of above-mentioned work forthwith ;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. Suresh Kumar Reddy Kalava, Advocate for the Petitioner, learned GP for Home for respondent No.1, Sri. K.C. Venkata Reddy, Standing Counsel for respondent Nos.2, 5 & 6, learned GP for Education for respondent No.3, Sri. Butta Vijaya Bhaskar, Standing Counsel for respondent No.4 and learned GP for Finance & Planning for respondent No.7, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

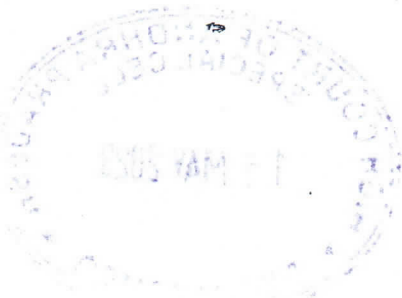
