Jaya Prakash Madasu, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased issue an appropriate Writ order or direction more particularly, one in the nature of Writ of Mandamus, declaring action of the respondents in not releasing the amount of Rs.1,99,999/- (**Rs.1,69,549 by the 3rd respondent and Rs.30,450/- by the 8th respondent**) from out of sanctioned amount of Rs.2,00,000/- vide **Beneficiary ID 102946315NH1744774** to the petitioner for construction of houses under YSR Rural Housing 2019-20 as bad, illegal, arbitrary, violate of principles of Natural Justice and violate of Articles 14, 21 & 300A of Constitution of India and consequently direct the respondents to forthwith release amounts to the petitioner expended for construction of house under YSR Rural Housing 2019-20 scheme to the tune of Rs.1,99,999/- ;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. Jaya Prakash Madasu, Advocate for the Petitioner, learned GP for Housing Dept., for respondent No.1, learned GP for Finance for respondent No.2, Sri. E.V.
