WHEREAS the Petitioner above named through his Advocate RAMALAKSHMANA REDDY SANEPALLI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents and in non payment of dues Rs.23,51,657/- pertaining to the work of Establishment of New Rythu Bazar at Rayachoty of A.M.C, Rayachoty in Kadapa District. executed under Agreement dated 18.01.2020 even after submission of bill is illegal, arbitrary and Violation of Art.14, Art.15, Art.19(1)(g), Art.21, Art.23 and Art.300A of Constitution of India and violation of clause and 68 and 69 of AP Standard Specifications and consequently direct the respondents to pay dues of Rs. Rs.23,51,657/- pertaining to the work of Establishment of New Rythu Bazar at Rayachoty of A.M.C, Rayachoty in Kadapa District along with 12% Interest from the date of expiry of one month from the date of submission of bill to till the date of payment.

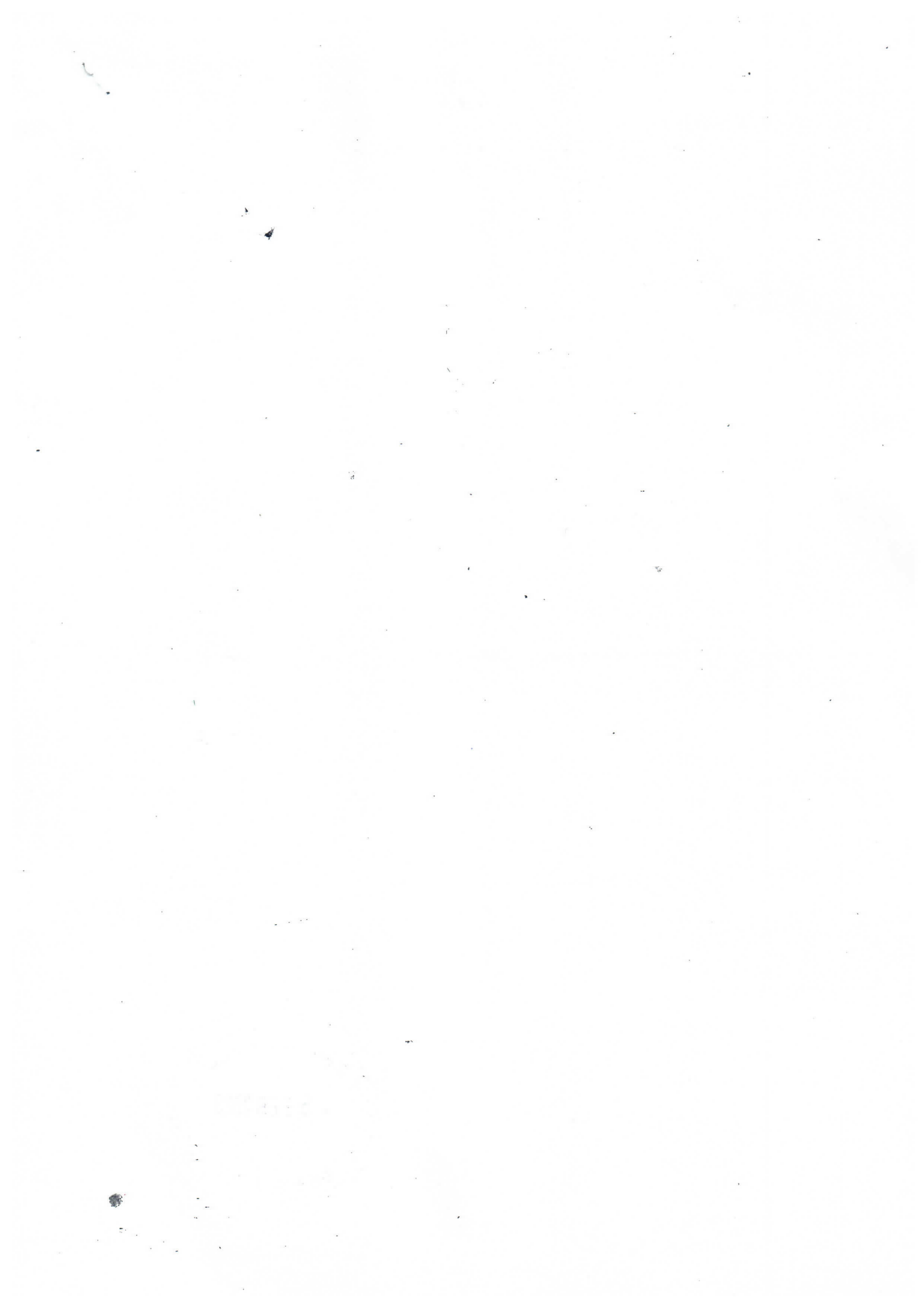
