Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of writ of Mandamus declaring the action of the respondents in disqualifying the petitioner in the technical bid in tender procurement in tender ID No. 625011 in the .OandM of CPWS scheme to Darsi and 52 other habitations in Prakasam District, for the year 2023 -24 with an estimated cost of Rs. 220.00 lakhs. and tender ID No. 625291 in the . OandM of CPWS scheme to Kanigiri constituency in Prakasam District, for the year 2023-24 with an estimated cost of Rs.395.00 lakhs. without any reason or explanation as arbitrary, illegal, high-handed and violative of Articles 14, 19 and 21 of the Constitution of India and consequently direct the respondents to receive and consider the price bid of the petitioner before finalising and also in awarding the tender or in the alternative to compensate the Petitioner with compensatory costs and pass such other order or orders as this Honourable Court may deem fit and proper in the facts and circumstances of the case.
