WHEREAS the Petitioner above named through his Advocate SRI.VENKATA SUNEEL REDDY P., presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in writ of Mandamus declaring the action of 3rd Respondent in issuing impugned proceedings RC No. SPL/B1/2022-2023, dt.30-05-2023 reverting the petitioner to the post of Staff nurse from the post of Head Nurse as punishment and posting to Government General Hospital, Ongole without following proper procedure is illegal, arbitrary, violation of Principles of Natural Justice and in violation of Articles 14, 16 & 311 of Constitution of India and to quash or set aside the impugned proceedings RC No.SPL/B1/2022-2023, dt.30-05-2023 issued by the 3rd Respondent and issue a consequential direction to the respondents to consider the petitioner to the post of Head Nurse.
