Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus, or any other appropriate writ, order or direction, declaring the action of the Respondents 2 to 5 in trying to illegally lay road through the Petitioner's agriculture land admeasuring Ac.2-00 cents in Sy.No.758, situated at Ananthatasamudram Village, Pullampet Mandal, Annamaiah District (erstwhile Kadapa District), without following due process of law, as illegal, arbitrary, without jurisdiction, unconstitutional and in violation of principles of natural justice
