Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ of mandamus or any other appropriate writ or direction declaring the action of the respondents No 2 and 3 herein in erecting unnecessary benches and obstructing way to the house and site and trying to encroach the petitioner land situated in Sy No 68-11A to an extent of Ac 0.55 cents of Lankapalli Agrharam Village 86 Panchayat ,Ungutur Mandal, Krishna District without initiating the proceedings under The Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013 Act No 30 of 2013 is not legal and the same is violative of Articles 14,21 and 300A of the Constitution of India and without following the due process of law and the procedure laid down under the Andhra Pradesh Panchayat Raj Act 1994 as illegal arbitrary against the principles of natural justice and consequently direct the respondents not to dispossess the petitioner from the possession and enjoyment of the land situated in Sy No 68-11A to an extent of Ac 0.55 cents of Lankapalli Agrharam Village AND Panchayat ,Ungutur Mandal, Krishna District and pass
