WHEREAS the Petitioner above named through its Advocate K. RATHANGA PANI REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature Writ of Mandamus, declaring the action of the respondents in not paying the admitted bill amounts of Rs. 1,14,584/-, Rs. 1,26,276/-, Rs. 1,16,825/-, Rs. 1,17,676/-, Rs. 1,15,047/- and Rs. 1,46,517/- to the Petitioner for the works of drilling of two bore wells at the worksite of APSWRSC at Arikera under the work repairs and Maintenance to APSWRSC at Arikera in Kurnool District, drilling two bore wells at the work site of construction of A.P Minority welfare residential school complex at Arekal in Kurnool District, drilling of bore well at the work site of maintenance and repairs to Govt. Boys Hostel, Brahmakotkur Village, Nandikotkur Mandal, Kurnool District and drilling new bore well source for the work of construction of building for Govt. Ploytechnic at Alur, Kurnool District vide proceedings dated 01.10.2018, 28.04.2018 and 21.10.2020 entrusted by the 3rd respondent, as illegal, arbitrary, violative of Arts.14 and 19(g) of the Constitution of India and consequently direct the Respondents to forthwith release the payment of above bill amount along with interest. ,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri K RATHANGA PANI REDDY Advocate for the Petitioner, and of GP FOR FINANCE AND PLANNING for Respondent No.1 and of Sri. G.V.S.Kishore Kumar, Advocate for Respondent Nos. 2

and 3, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

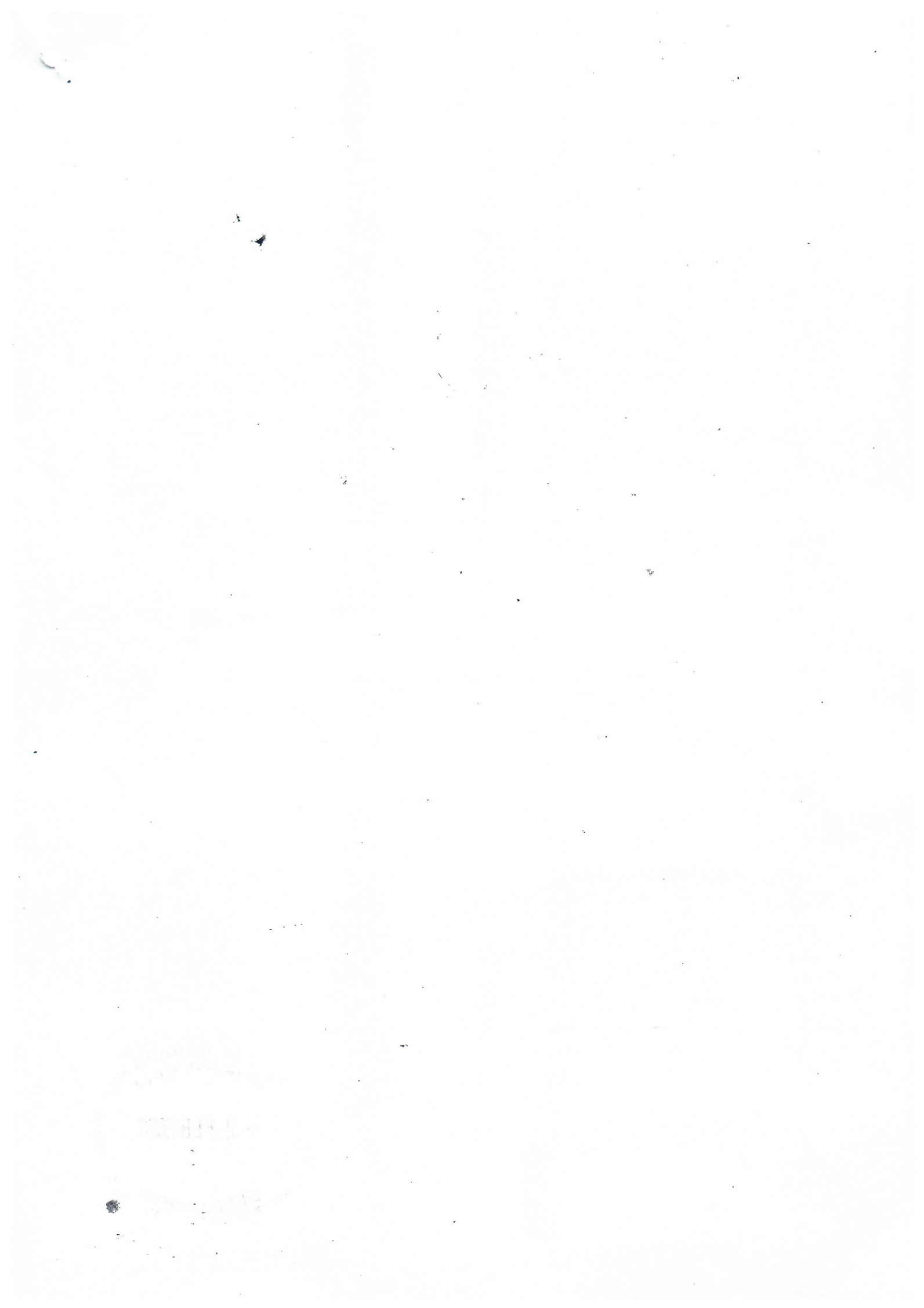
