Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the inaction of the part of Respondents 2 to 4 in interfering with the possession and enjoyment of the vacant site of the petitioner that is extent of 230.77sq.yds out of 320 sq.yds in R.S.No.79-11A of within the boundaries. North. In the land of Gavireddy Ramanamma; East: Vacant site of remaining land of Dendhukuri Satyanarayana Raju; South: R and B Road way of Narsipatnam to Thalapalem; West: In the MRO office complex of Makavarapalem Village, Makavarapalem Mandal, Visakhapatnam District, situated exactly to the Eastern side of the Respondent No.2 office building, demanding the petitioner not to proceed with the fencing of the above site claiming the said property as Respondent No.2 property though it is a private property purchased by petitioner Vide. Reg. Document No. 3718/2020, is highly arbitrary, unlawful, illegal, is nothing but high handed, unlawful, unreasonable and in violation of the Principles of Natural Justice and Fundamental Rights guaranteed under Art.14, 21 and 300-A of the Constitution of India and Rules made there under by consequently directing the Respondents not to interfere with the property of petitioner that is extent of 230.77sq.yds out of 320 sq.yds in R.S.No.79-11A of within the boundaries. North. In the land of Gavireddy Ramanamma; East: Vacant site of remaining land of Dendhukuri Satyanarayana Raju; South: R and B Road way of Narsipatnam to Thalapalem. West. In the MRO office complex of Makavarapalem Village, Makavarapalem Mandal, Visakhapatnam District.

East.Vacant site of remaining land of Dendhukuri SatyanarayanaRaju; South. R/66-B Road way of Narsipatnam to Thalapalem; West: In the MRO office complex of Makavarapalem Village, Makavarapalem Mandal, Visakhapatnam District., either by evicting him or obstructing him from enjoying his property until further orders of this Honourable Court, Pending disposal of WP 18122 of 2023, on the file of the High Court.

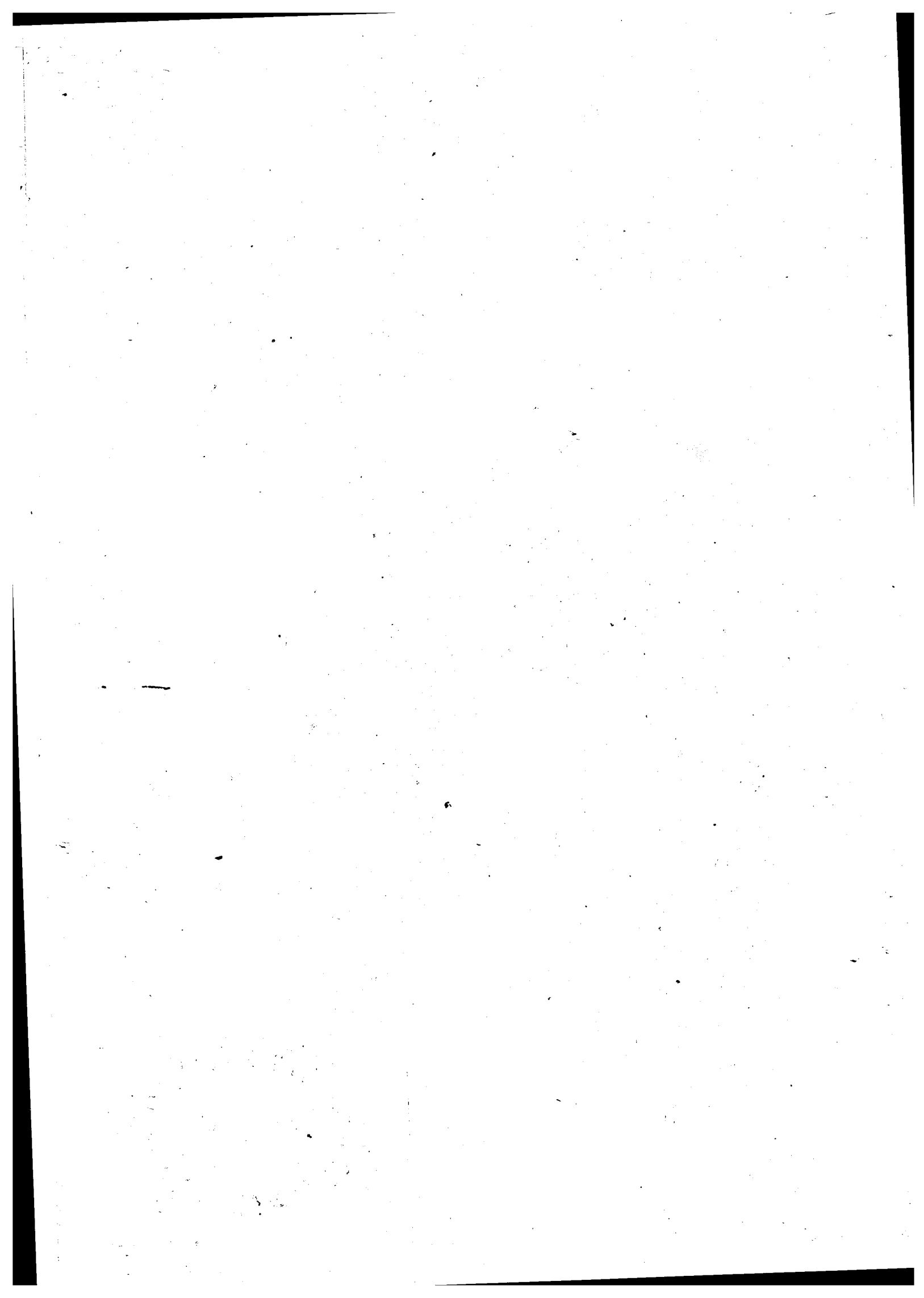
