WHEREAS the Petitioner above named through his Advocate Sri Ramesh Babu Talluri, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue order, writ or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not releasing the amount of Rs. 5,00,000/- towards financial assistance to my son Koppula Hemanth as per G.O.Ms. No.29 dated 27.08.2016 under "NTR Videshi Vidyadarana," despite sanction of funds by the Government with Application ID No.OV2019123080, as illegal, arbitrary and unconstitutional and consequently direct the respondents the amount of Rs. 10,00,000/- towards financial assistance to the petitioner's son Koppula Hemanth under Application ID No.OV2019123080 ;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Ramesh Babu Talluri, Advocate for the Petitioner, learned GP FOR SOCIAL WELFARE for respondent Nos.1,3,4 & 5 and learned GP FOR FINANCE AND PLANNING DEPT., for respondent No.2 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
