Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction mostly one which is in the nature of a Writ of Mandamus declaring the action of the Respondents in Sy No 90/2 an extent of Ac.0.38 cents in Jaripinaidu peta revenue village , Rasta Poramboke adjacent to the Burial Ground of Sanapalavani peta and Pudivalasa Villages, allotted to 14 beneficiaries of Tamminaidu peta Grama Panchyat by closing the Rasta poramboke, and allotted, under Housing scheme which is illegal, irregular, arbitrary, and contrary to law and violations of principals of Natural Justice and offends the rights of the petitioner under Article 300-A ,14, 21, of Constitution of India, and consequently direct the respondents not to allot the Rsata Poramboke in Sy No 90/2 of Tamminaidu peta Grama Panchyat and contrary to the Board Standing Orders (BSO) 15 (4) Of A.P Revenue Board Standing Orders.

IA NO: 1 OF 2023:

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to allot and making any construction proposal in the Sy No. 90/2 Rasta Poramboke to the beneficiaries of Tamminaidu peta Grama Panchyat under Housing scheme Etcherla Mandal of Srikakulam District, Pending disposal of WP 19273 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri UMASANKAR LOKANADHAM Advocate for the Petitioner and of GP FOR REVENUE for the Respondent Nos.1 to 4, the Court made the following
