01.	04.08.2023	<u>NV,J</u> Learned counsel for the petitioner would submit that the impugned proceedings in No.SKU / CDC / A1 / Affiliations/2023, dated 20.07.2023, has reference of orders of Vice Chancellor, as such the Vice Chancellor has no power to issue any orders with regard to affiliation or de-affiliation of the institution. He also further submits that issuance of impugned proceedings prior to commencing of counselling is nothing but disabling the petitioner-institution to defend themselves, as such, it is against principles of natural justice. Furthermore, learned counsel would submit that the respondent University did not conduct inspection or verification basing upon the explanation submitted by the petitioner and straight away deleted the name of the institution in online counselling. On the other hand, the learned Standing

		Counsel for Respondent Nos.2 to 4, refuted the contentions made by the learned counsel for the petitioner. He would submit that the petitioner institution has failed to fulfill any of the conditions prescribed in the permission / recognition / affiliation accorded to that institution. Even after the institution were provided with an opportunity to rectify the defects and afforded reasonable opportunity and time, they were not complied with. As such, the proceedings dated 20.07.2023 issued by the university is in consonance with the rules of the University and warrants no interference of this Court. Heard the learned counsel for the petitioner and learned Standing Counsel for Respondent Nos.2 to 4. Upon perusal of the record, it appears that a <i>prima facie</i> case is made out in favour of the petitioner institution. Issuing proceedings dated 20.07.2023 before commencing the counselling schedule is nothing but creating panic among the petitioner-institution, thereby, disabling them to take any records. Moreover, the University even

		did not conduct inspection or verification, basing upon the explanation submitted by the petitioner. Hence, there shall be an interim suspension of the proceedings in No.SKU / CDC / A1 / Affiliations / 2023, dated 20.07.2023, issued by the 3rd Respondent - University, till further orders. Further, Respondent Nos.1 to 4 are directed to enlist/include the petitioners-colleges in the list of colleges for counselling for the academic year 2023-2024 on par with colleges mentioned in G.O.Ms.No.22, Higher Education (R.M.) Department, dated 12.07.2023, as per the schedule prescribed, pending further orders. Post the matter after four weeks. NV, J <u>Note:-</u>Issue cc by 07.08.2023 B/o SSN
