Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of a writ of mandamus declaring the action of the 1st respondent in issuing G.O. Rt No. 677 Revenue (Excise) Department dated 31-07-2023 wherein formulating the guidelines for allocation of personnel between Special Enforcement Bureau and Prohibition and Excise Department and vice versa and consequential proceedings vide C.R.No. 2116/2023/CPE/A1-2,5 and 6 dated 01-08-2023 of the 2nd respondent wherein allotted the petitioners to Special Enforcement Bureau is illegal, arbitrary, unjust and violation of Article 14 and 16 of the constitution of India and consequently set aside the same by directing the respondents to permit the petitioners to continue in Prohibition and Excise Department;

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased suspend the operation of G.O. Rt No. 677 Revenue (Excise) Department dated 31-07-2023 and consequential proceedings vide C.R.No. 2116/2023/CPE /A1-2, 5 & 6 dated 01-08-2023 of the 1st and 2nd respondents in so far as the petitioners are concerned and continue them in Prohibition & Excise Department, pending disposal of WP 20135 of 2023, on the file of the High Court.
