Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ or order or direction more particularly one in the nature of Writ of Mandamus declaring the highhanded action of the Respondents in trying to dispossess the Petitioners from their respective House Site Plots to an extent of Ac.0.03 each in Sy Nos.94 of Solikiri Village, Baleru Gram Panchayat limits, Bhamini Mandal, Parvathipuram Manyam District to provide house sites to the beneficiaries under "JAGANANNA ILLU under YSR HOUSING SCHEME" without considering as direction of this Hon'ble Court in W.P.No.14016 of 2020 dated 14.08.2020 and latest representation dated 10.07.2023 as also following due process of law as illegal, arbitrary, and violative of principles of natural justice, colorable exercise of the power as also contrary to Article 21 and 300A of the Constitution of India and consequently direct the Respondents not to dispossess the Petitioner from their respective House Site Plots to an extent of Ac.0.03 each in Sy No.94 of Solikiri Village, Baleru Gram Panchayat limits, Bhamini Mandal, Srikakulam District except under due process of law;

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents not to dispossess the Petitioner from their respective House Site

Plots to an extent of Ac.0.03 each in Sy No.94 of Solikiri Village, Baleru Gram Panchayat limits, Bhamini Mandal, Srikakulam District except under due process of law and pass, Pending disposal of WP 20449 of 2023, on the file of the High Court.
