Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or a Writ, particularly one in the nature of Writ of Mandamus

declaring the inaction on the part of the respondents, particularly that of the respondent No.4 Tahsildar in granting house site pattas in favour of the petitioners in the open site in an extent of AC 0.18 cents adjacent to the church by the side of Ponnathota. road in the Sy. No. 46/2B1 of Gudemcheruvu Village. Jammalamadugu Mandal, YSR Kadapa District, and in preventing the unofficial respondents Nos. 5 to 10 in illegally and highhandedly occupying the said piece of land on the claim of fake pattas and in not cancelling the fake pattas claimed to be in the names of the unofficial respondents Nos 5 to 10 as illegal and void and consequently passing an order directing the respondents, particularly the respondent No. 4 to grant house site pattas to the petitioners .

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to pass an Interim order directing the respondents particularly the respondent No. 4 to stop the unofficial respondent Nos 5 to 10 from illegally and highhandedly occupying the said piece of land in an extent of AC 0.18 cents adjacent to the church by the side of Ponnathota road in the Sy. No.46/2B1 of Gudemcheruvu Village. Jammalamadugu Mandal, YSR Kadapa District, Pending disposal of WP 20488 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Y KOTESWARA RAO Advocate for the Petitioners and of GP FOR REVENUE for the Respondent Nos. 1 to 4, the Court made the following

ORDER
