Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly a Writ in the nature of ~~of~~ Mandamus, declaring the action of the respondent No.4 in attempting to dispossess the petitioner from the land in an extent of Ac.6.50 cents out of Ac.29.22 cents in Sy.No.364/1A of PemmadaPalli Village fields, Rayachoty Mandal, Annamayya District by rejecting the Form VI-A application submitted by the petitioner through the Endorsement in Ref.B/818/2023, dated 01.08.2023 issued by him and by updating the revenue entries in the Web-land adangal as if the same is belonged to Government as arbitrary, illegal colourable exercises of power and contrary to the provisions of the Andhra Pradesh Rights in Land and Pattadar Pass Books Act, 1971 and the Rules made thereunder and also the well established legal principles apart from being violative to the fundamental and Constitutional rights guaranteed to him under articles 14, 19, 21 and 300-A of the Constitution of India and consequently (a) to direct the respondents not to interfere with the petitioners rights over the land in an extent of Ac.6.50 cents in Sy.No.364/1A of PemmadaPalli Village fields, Rayachoty Mandal, Annamayya District by setting aside the Online entries in respect of the land in an extent of Ac.6.50 cents out of Ac.29.22 cents in Sy.No.364/1A of PemmadaPalli Village fields, Rayachoty Mandal, Annamayya District. (b) to direct the respondent No.4 to reconsider the Form VI-A application No.DER012301465300, dated 01.07.2023 by setting aside the Endorsement in Ref.B/818/2023, dated 01.08.2023 issued by him .

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to interfere with the petitioner rights over the land in an extent of

Ac.6.50 cents in Sy.No.364/1A of Pemmada Palli Village fields, Rayachoty Mandal, Annamayya District, Pending disposal of WP 20543 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri V R REDDY KOVVURI Advocate for the Petitioners and of GP FOR REVENUE for the Respondents, the Court made the following

ORDER

By the date of next adjournment, the respondent No.4 shall take necessary action on the petitioner's application dated 01.07.2023. Further, *status quo* with regard to the subject matter property existing as on today shall be maintained, in all respects, till the date of next adjournment."
